This is a testament to the importance of the topics we address, and to the commitment of our members – especially those who have supported the UKIEG for a long time, including UKIEG's co-founder and first Chair, Paul Harrison, who was fittingly present at this year's Conference.

The Committee is happy to report that we now have around 250 registered members from a wide variety of backgrounds and affiliations, including built environment, epidemiology, public health, policy, industry and many others. ANNUAL CONFERENCE, JUNE 2013: UKIEG CELEBRATES 10 YEARS!

Our conference this year marked the 10th anniversary of the founding of UKIEG, with the first scientific meeting being held in Leicester back in 2003. Paul Harrison was there then as the first Chair of UKIEG as was our secretary Isabella Myers who gave the keynote presentation: it was fitting that both should also be present at this year's conference.

This was another very successful meeting with 10 speakers, 9 posters and around 40 delegates in attendance. We enjoyed an excellent Keynote presentation from Paul Wilkinson, Professor in Environmental Epidemiology at LSHTM, who spoke on 'Health Refurbishment' - including the health impact of 'decarbonising' the UK's built environment, with some remarks based on his personal experiences in attempting to achieve good air quality in an extension/refurbishment of his own home. The other talks were all topical and interesting, covering a diverse range of topics. These formal 20-minute papers were supplemented by a stimulating 'quick-fire' poster session in which authors had a strict two minutes to describe their poster.

The AGM was also very well attended and provoked good feedback from delegates when asked for thoughts and ideas for future conference topics and venues which the committee will consider further. Suggested topics included:

- IAQ monitoring and bio-monitoring; measurement strategies and methods; modelling techniques
- Health impact of building fabrics
- Daylighting: newbuild vs. retrofit
- IAQ in retrofit housing
- How to deal with the conflict of air tightness vs. ventilation
- MVHR vs DCV: pros and cons.
- IAQ and future climate change scenarios
- IAQ success stories

The final discussion session of the meeting was a lively affair with many contributions from the audience, including much debate revolving around the tricky play-off between energy conservation (zero carbon policy) and the achievement of good indoor air quality in buildings.

It became clear that there is often a mismatch between policy objectives and intentions and actual outcomes, due variously to frequent misapplication, misunderstanding and/or mismanagement. The impact of such failures on public health could be considerable but is presently largely unknown. The need for post-occupancy evaluation was stressed, with a focus on whether alleged 'improvements' actually work. One very practical suggestion made was the creation of a UKIEG database of monitoring methods, and this is something the Committee will follow up, possibly via the UKIEG LinkedIn Group.

CONSULTATIONS, NEWS & FUNDING OPPORTUNITIES

1) Consultation on a Bill to prohibit, in Scotland, smoking in private vehicles while a child under 16 years of age is present

The consultation period for this document closes on the **30th August 2013**.

You may want to add your voice to the consultation process and to spread the word to others who may have an interest in contributing to the debate about reducing children's exposure to SHS. The consultation is open to the end of August and there is no reason why those outside Scotland can't add their comments.

2) Launch of NIHR SPHR's Public Health Practice Evaluation Scheme (PHPES)

Deadline for applications for this first round: **midday, Monday 29th July**

NIHR SPHR's Public Health Practice Evaluation Scheme (PHPES - pronounced Fez!) enables people working in public health who are introducing innovative initiatives aimed at improving health, to work in partnership with SPHR to conduct rigorous evaluations of their cost-effectiveness. Eligible projects / initiatives should aim to improve population health and / or reduce health inequalities and have the potential to be of benefit in other parts of England. They should have secure funding for the duration of the evaluation, which would normally be no more than 2 years. 3) Royal College of Obstetricians and Gynaecologists (RCOG) Scientific Impact Paper;

This new Report, 'Chemical exposures during pregnancy: Dealing with Potential, but Unproven, Risks to Child Health', raises awareness of the current issues surrounding chemical exposure during pregnancy and offers advice for women to make informed decisions that will predispose their baby to have the best possible health. The authors explain that under normal lifestyle and dietary conditions, pregnant women are exposed to a complex mixture of hundreds of chemicals at low levels through many avenues, including consumption of food, use of household products,

over-the-counter medicines, as well as personal care products (PCPs) and cosmetics. Recommendations made in the paper include: using fresh food whenever possible by reducing foods in cans/plastic containers, minimising the use of PCPs, avoiding paint fumes and use of all pesticides, and only taking over-the-counter medicines when necessary.
